The Advisory Board Meeting for German Township was called to order at 6:00 pm. Board members present were Chairman, Jim Pepples, Secretary Leta Johnson, Dolores Schocker, and Trustee Thomas McClanahan. Refer to sign in sheet for guests.

Oath of Allegiance was said

Dolores Schocker read the secretary's report. Leta Johnson made a motion to accept as read. The motion passed 3-0

The Fire Marshall Dave Cherone inspected the building for human capacity. The large room down stairs should hold 60 people, the large room upstairs will hold 32 people and the small room up stairs will hold 8 people.

Winter had to remove the gutters off the north side of the community building. Three estimates were submitted. Classic Gutter would do the job for \$425.00; Frank Tirotta would do the job for \$370.00 he would install the gutters and down spouts plus remove the old; and Hochstetler Gutter would do the job for \$425.00. Dolores Schocker made the motion to accept Frank Tirotta's bid and Leta Johnson seconded the motion.

The Cemetery Committee had a meeting on April 24, 2018. The boy and girl scouts will be working on the Burkard Cemetery on Adams Road.

The Trustee went to the County City Building

and picked up two maps of Secman Township and had them framed. One reason for the maps was for street referral for poor relief. Also was interested in the township population. 4570 residents

Because the regular Advisory board was to be on election day Valois Schosker made a motion to change it to Wednesday, May 9, 2018 and Leta Johnson recorded the motion

There were questions about poor relief. Tom McClanahan said we will pay the rent, electric bill or water bill. The second time they come for help they are sent to the Goodwill to work. They can return in 6 months and be revalued again. But Skilton ask for copies of the paper work and Tom McClanahan said he couldn't have the paper work but could stop by the office and review it.

Under old business someone ask the question about conflict of interest between the township and board members.

Under good of the township: Jill Kurzhall brought ^{up} about the stores on Postage Road in our neighborhood. Dollar General, Meijer, and Walmart should close between 12:00 pm and 6:00 AM to help cut down on crime. It was also brought up about all the trash that needs to be cleaned up.
